 - ESA SME Office communication channels




Method: Survey distribution

- The SME4SPACE survey "CONSEQUENCES OF THE GEOPOLITICAL SITUATION FOR THE EUROPEAN SPACE SMES" remains active since its release
- The survey included 10 questions in a multiple choice or free text format
- Qualitative data were collected from 46 replies where the preliminary results are identified and highlighted in the present report



Size of space entity

- The chart below show the type of the space entity that participated in the survey.
- The majority of the replies were indicated by Small Companies with 56,5%. Large Enterprise 2.2%







Main issues among space entities


- Listed below are the issues of the space entities have mostly been confronted with due to the Ukrainian war.
- Supply chain problem(s) 54,3%
- Commodity price increase 41,3%
- Project(s) delays or suspension -32,6%
- Procurement issues such as availability of critical items, components or material -28,3%
- Loss of turnover/Income/revenues 26,1%
- Termination of ongoing/ future contract(s) 19,6%
- Project(s) termination 8,7%





Expected loss in terms of markets and related turnover for the current and coming year

- In this question the majority of the companies replied regarding 2022, the answers of which are found below:
- "Less than 20%": 45,6% of replies
- "None": 17,3% of replies
- "Between 21% 50%": 8,69% of replies
- "N/A Other": 8,69% of replies
- "Between 51% 80%": 2,17 % of replies





Desired concrete measures to mitigate the impact of the Ukrainian crisis In this question the companies had to choose among various actions that could tackle the negative effects of the Ukrainian crisis. The dominant concrete measures are listed below:

- Increase of budget for ongoing projects 39,1%
- Review of pricing for firm fixed prices 37 %
- Modify the priorities in the ongoing programmes (e.g. Critical Technologies for Non Dependence) -34,8%
- Assistance in looking for alternative suppliers 26,1%
- Bridging financing 17,4 %
- Accelerate ongoing developments (e.g. electric propulsion) 15,2%
- Assistance in looking for alternative flight opportunities 13%
